What is a JLUS?

A federally funded program to promote cooperation administered by DOD/OEA

A proactive approach to achieve a balance to sustaining missions at NSF Dahlgren and the economic development viability of communities

A preventative measure to encourage compatible development

Initiated in 1985 by the Office of Economic Adjustment, (DOD).

Over 130 JLUSs have been completed nationally.



A JLUS is:


- a collaborative process
- Set of recommendations to mitigate or prevent incompatible development associated with the military mission

A JLUS is NOT:

- a regulatory document
- an enforceable action

A JLUS is a body of information for decision makers of all levels to assist in making informed decisions

A JLUS requires follow-on support by all stakeholders, including the public, to implement the recommendations



JLUS Objectives

Community

- Protect the health, safety, and welfare of residents / maintain quality of life
- Manage development in the vicinity of military installations that would interfere with the continued operations of these facilities
- Protect opportunities for new growth in an economically, environmentally, and socially sustainable manner
- Maintain the economic vitality of the community / region

Military

- Protect the health, safety, and welfare of the military and civilian personnel living and working at or near the military installation
- Ensure the ability of the installation to achieve its mission, maintain military readiness, and support national defense objectives



JLUS Approach

Goal is to link to geographic areas to the issues

- Identify areas by specific compatibility issues and concerns
- Narrow focus to areas where the issues exist
- Minimize areas that require controls or policies
- Link solution types and tools to specific areas

Develop an implementation strategy for preventing and mitigating encroachment:

- Recommendations will involve local jurisdictions, state and federal agencies, private organizations, and / or military
- Tie recommendations to specific military areas of concern



- Engaged Stakeholders in collaborative planning process
- Refined compatibility areas of concern
- Identified strategies and tools to assist decision-makers with informed decisions
- Conducted Public Review and Comment Period
- Policy Committee Accepted Final Report
- Communities and Agencies start Adoption Processes

How Issues are identified


- Data research and assessment

JLUS Compatibility Assessment

35 issues across 24 compatibility factors:

- Communication / Coordination (4 issues)
- Frequency Spectrum (4 issues)
- Land / Air Space competition (3 issues)
- Land Use (3 issues)
- Legislative Initiatives (3 issues)
- Noise (5 issues)
- Safety Zones (3 issues)
- Other Issues (10): Biological Resources, Energy Development, Housing Availability, Infrastructure Extensions, Light and Glare, Roadway Capacity, Vibration



How the recommendations affect Charles County communities:


- Greater protection of public health, safety, welfare
- Improved communication between NSF Dahlgren, local jurisdictions and the public – shared awareness of economic / physical relationships and mutual impacts
- Greater transparency in planning processes to address compatibility now and into the future
- Consistency in approaches to addressing compatibility



Key Strategies for Charles County

Communication / Coordination

- Participate in a JLUS Implementation Coordination Committee to provide oversight and monitoring of the JLUS implementation
- Incorporate NSF Dahlgren as review agency on development apps
- Formalize communication through MOUs
- Consider an Intergovernmental Coordination Element in Comp Plan
- Assist with public outreach efforts
- Improved signage

Energy Development

- Consider enhancing Alternative Energy Ordinance
- Coordinate with the DOD Siting Clearinghouse
- Identify and map locations suitable for wind energy development


Housing Availability

- Incorporate transient housing needs in Comprehensive Plan
- Investigate feasibility of rental housing development partnership with Navy / private developers



Land Use

- Update Comprehensive Plan with military compatibility policies
- Create a Military Compatibility Overlay District (MCAOD):
 - Safety Military Compatibility Area (MCA) Bird/Wildlife Aircraft Strike Hazard (BASH) Relevancy Area
 - Noise Military MCA
- Update Zoning Code and Maps to be consistent with Comprehensive Plan updates
- Incorporate imaginary surfaces into zoning code



Legislative Initiatives


- Develop an enhanced real estate disclosure statement
- Request the State of MD to update real estate disclosure requirements to include firing ranges and associated impacts

Light and Glare

Consider adopting a Dark Sky Ordinance


Roadway Capacity

Monitor capital improvements for roadway capacity



Noise

- Identify noise compatibility policies for inclusion in planning documents
- Identify noise contours on zoning maps and planning documents
- Educate local builders on sound attenuation
- Consider a voluntary sound attenuation retrofit program






JLUS Recommendations: MCAOD







Actions to implement recommendations:

- Charles County Commissioners consider acceptance of JLUS
- Acceptance by other participating jurisdictions

Next Steps (after study report acceptance by Commissioners)

- Establish JLUS Coordination Committee
- Identify strategies by timeframe for execution
- Consider applying to OEA for additional funding to implement strategies that require studies or additional analysis
