

SHORELINE STABILIZATION & LIVING SHORELINE



NAVAL SUPPORT FACILITY - INDIAN HEAD (Charles County, MD)

> In partnership with Southern Maryland RC&D and the Department of Navy, the Charles Soil Conservation District provided the project management services for the installation of shoreline protection measures – performed in three phases.



Phase One included the stabilization of steep slopes & shoreline along approximately 3,000 linear feet of the Potomac River . (Project Cost: \$5.1 M)





NATURAL RESOURCE CONSERVATION SERVICE

USDA/NRCS PARTNERSHIP TECHNICAL ASSISTANCE

Through a revolving Grant Agreement - RC&D assists USDA/NRCS with technical assistance in field offices throughout the 23 counties in the state of Maryland. These soil technicians / engineers, support specialists, foresters, and grazing specialists provide landowners with accelerated implementation of conservation practices through financial assistance programs.

LAND PRESERVATION PARTNERSHIP

US NAVY (READINESS & ENVIRONMENTAL PROTECTION INTEGRATION PROGRAM - REPI)

The Department of Defense (DoD)'s REPI Program is a key tool for combating encroachment that can limit or restrict military training, testing, and operations. The REPI Program protects these missions by helping remove or avoid land use conflicts near installations and addressing regulatory restrictions that inhibit military activities.

STATE GOVERNMENT (RURAL LEGACY PROGRAM)

The Rural Legacy Program was created to protect large, contiguous tracts of Maryland's most precious natural resource lands through grants made to local Sponsors (generally County governments and land trusts). The Rural Legacy Program is administered by the MD Department of Natural Resources.

COUNTY GOVERNMENT (LAND PRESERVATION PROGRAM)

County governments support the Rural Legacy Program through their own land preservation programs to protect our rural character, working lands, and natural resources, and help protect the military's mission in our community.

LANDOWNER

Landowners receive monetary compensation for agreeing to have a conservation easement recorded on their property.

LAND TRUST (RC&D)

The land trust works with all of the partners to process, finalize, and monitor the conservation easements.

REPI – A TOOL FOR PRESERVATION

REPI

United States Department of Defense (DoD)

Readiness and Environmental Protection Integration (REPI) Program

- Supports <u>cost-sharing partnerships</u> between military services, state and local governments, and private conservation groups to purchase land interests or easements from <u>willing landowners</u>
- Easements allow landowners to maintain ownership of their property as a farm or forest but prevent future development as identified in the terms of the easement
- As of Sept. 2019, REPI has protected 688,000+ acres at 109 locations in 33 states


NAS PATUXENT RIVER

The Navy's principal research, development, test, evaluation, engineering, & fleet support activity for naval aircraft, engines, avionics, aircraft support systems & ship/shore/air operations

- Employs 20,000+ people
- ~150,000 annual air operations
- 40+ different aircraft including jet, propeller, helicopter, and unmanned
- 1.5 million acres special use airspace (Atlantic Test Range)
- ATR covers much of Southern Maryland, and conservation easements within this area are eligible for REPI Program funding


